### Office Policies

#### Fees:

- (1) initial 30" consultation is free.
- Initial appointment fee: \$125.00 (lasts approx. 1 hour).
- **Initial Deposit: \$25.00 Required to hold appointment** - Balance due at appt.
- All phone consults must be paid in FULL prior to appointment date.
- Follow up visits will be billed at \$75.00 per hour.
- Supplement advice will be charged in 15 minute segments at \$15.00.
- Phone consults are billed at \$75.00 per hour.

#### **All initial appointment deposits must be pre-paid online.**

Debbie does not take payments via telephone. To schedule an initial appointment, you must pay a non-refundable \$25 deposit prior to the appointment. This policy is in effect on account of the excessive number of clients who scheduled an initial appointment and then do not show up. Debbie does not double book clients, and spends over an hour with all new clients. No show clients waste Debbie's valuable time and prevent other clients from scheduling appointments.

My website uses PayPal for prepayment. You do not have to have a PayPal account to pay ahead of time, but you do need to have a debit or credit card. If you need to reschedule your appointment, and do this at least 48 hours prior to your appointment, you do not need to make another deposit.

**Cancellation Policy:** If you cancel your appointment less than 48 hours prior to the scheduled time, or if you do not show up, you do not get the deposit refunded. If you make an appointment and do not pay the \$25 deposit, your appointment will be cancelled. If the weather is bad and you are uncomfortable driving, please notify Debbie via email as soon as possible. Your appointment will be rescheduled without penalty. If you are uncomfortable using PayPal, you can pay the deposit by mailing a check for \$25 at least 5 days before your appointment. For clients that mail a check, your appointment will be held for 3 weekdays after you make the appointment online. If a check does not arrive within three weekdays of making your appointment, your appointment will be cancelled and your check returned

At the time of your initial appointment, the balance of \$100.00 is required. This can be paid via cash, credit card or check. Deposit of \$25.00 is required for the initial appointment only. Debbie does not accept insurance and does not submit forms to insurance companies. There is a \$45 bounced check fee.

#### Discontinuation of Therapy

- In the event that nutritional therapy is discontinued for any reason, any outstanding balance is immediately due.
- Prepaid Packages are NON-REFUNDABLE.
